### REACH DECLARATION OF CONFORMITY

The European Parliament approved the regulation no. 1907/2006/EC concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) of 18 December 2006, which came into force on the 1<sup>st</sup> of June 2007. The company HAFNER Pneumatika Kft. knows the specifications of this regulation.

HAFNER Pneumatika Kft. supports the objectives appointed by REACH. Our company is committed for the responsible treatment of chemicals and for the environment. For the safe production and for the safe use of our products, we maintain a very close connection with our suppliers and customers.

HAFNER Pneumatika Kft. is qualified as a downstream user according to REACH, so it is not directly responsible for the materials registration. We are in close relation with our suppliers, we are constantly informed about their supplied materials, and we comply with the regulations of the safety datasheets of the materials.

In line with article 33 of the Reach regulation, HAFNER is required to inform its customers about any item manufactured or sold with a substance concentration exceeding the 0.1% (w/w) in accordance with the most updated candidate list. HAFNER will provide sufficient information to allow safe use of the item including, as a minimum requirement, the name of the substance within a period of 45 days from the date of receipt of the request, as indicated by the Reach regulation.

Lead (CAS No. 7439-92-1) has been added to the candidate list on June 27th, 2018; some HAFNER product, in particular but not exclusively valves, operators and solenoids, are impacted. Lead is a component of brass (copper alloy). This substance may be present with a concentration greater than 0.1% (w/w) in our products. Exclusion: our full-stainless-steel program (316L) and our pneumatic tubes.

Except for the lead, we hereby declare that none of the HAFNER products are known to contain any other of the 191 substances of Very High Concern (SVHC) as intentionally added components or as excepted process impurities above the threshold of 0.1%, nor any of the 43 substances mentioned in the Annex XIV since June 13th, 2017. In any case, the normal or reasonably foreseeable use of our articles doesn't require particular precautions. The only recommendation is to avoid cutting, drilling (or similar operation) on our articles, as this could cause exposure to the above substance or its dispersion in the environment. It should also be noted that none of our articles contains substances intended to be intentionally released during normal or reasonably foreseeable use.
